During the July County Commission meeting, Commissioner Ward McDaniel discussed the old courthouse located in the center of Wewahitchka and its condition after

the county employees did an inspection of the buildings condition the day prior to the meeting. The big question was what was the possibility of restoration of the main building? Was the big question.

County Administrator, Michael Hammond, said that he personally inspected the building inside with several other county employees and noted that the structure was sound, the windows are okay, and it was, "dry as a bone inside." As did others reported to the board as well.

But the old jail, not part of the original structure, would have to be removed with engineering supervision. This is necessary to ensure no damage will be done to the old courthouse walls in the process. There is a possibility that the county work crew could take down the jailhouse to save money instead of a hiring a contractor. The county grant writers were instructed to basically get busy on the project. To everyone's delight the county is moving to bring back the old courthouse and upgrade it to today's standards. Commissioner Ward McDaniel said the first step would be to bring the electrical up to current requirements so the power could be turn on. The attitude of the Board was positive on the restoration project and the outlook appears bright folks!

We will be celebrating the 100th year anniversary of Gulf County in 2025. Construction on the old courthouse was started in 1925 and completed in 1927.

THE HISTORICAL VIEW OF "FIRST BAPTIST CHURCH OF WEWAHITCHKA"

West Arm Creek bridge just north of the sweetest little city in Florida was the beginning of what we now call today Wewa. Just to the right before you get to the bridge is Jehu Cemetery Road. As you come around the road on the right you would of seen the original First Baptist Church of Wewahitchka (having been organized about 1840). It was built by the pioneers who

settled here back in the beginning of the state of Florida (circa 1838).

For those that remember Bo John Lester and where his house is located, that is the very spot where the original First Baptist



Church stood. Later in 1891, the church building was moved to its present location today on highway 71. It was pulled down the road by oxen, from Jehu, leaving the gravesite as it is today. The Deacons (Trustees) E.Z. Taylor, Dawson Stone, and N.A. Connell were listed on the original deed.

The old church was rolled down the dirt road on large tree trunks to sit directly facing Highway 71, about a mile south to its present location. Later in years, the church, which was

moved back and turned to its side, becoming the educational building later. I remember sitting in the chair on a Wednesday night, many years ago, looking up at the ceiling trying to see the remains of the old church structure. One evening after the service, I asked Brother Mike Stroud what part of the building was the original church? He told me to take a chair and look up in the drop ceiling that had been removed for some lighting work. I saw that the original ceiling was way up, a large void was present between the drop ceiling and the top of the roof. A Wow! moment for me. I love Wewa history as you all know by now. So, this was a nice treat for me. I finally saw what was to see and understand just how big the old church was originally. Brother Mike loves to work on the Baptist Church and thus knows nearly every inch of the old parts. Our First Baptist Church is one of the oldest in the State of Florida.

In the early years of Wewa life, preachers would come down from our neighbors in the north end of the county (we were part of Calhoun County back then, prior to 1925) from Blountstown and from the south, Apalachicola as well. They were known as Circuit Preachers back in the day, traveling to areas that had no preachers' pastors or church buildings. Remember this is in the early pioneer days of Florida. These preachers traveled through the woods on dirt roads and trails with swamps, bugs, snakes as well as bears and Indians. No telling what else all in the name of the Lord to share the gospel ministering to anyone that came to the meetings.

They were welcomed and paid for their time as well as a dry place to sleep while they visited Wewa and its surrounding area. God was blessing our ancestors with His word, via horseback and tough men that knew his word, sharing it with a passion most of the time. They also gave our pioneers the latest news and shared their love, including letters from relatives that lived north or south from us. Blountstown and Apalachicola conducted services monthly.

During the early part of the last century, some of the pastors who served were the Rev. Wright (1906), Rev. Juda (1917), Rev. Bryant (1920), Rev. Bridges (1921), Rev. Wilkes (1930), Rev. Garrett (1935), Rev. Moncrief (1936), and Rev. Hodges (1936), to name a few. During WWII years, the church was served by Rev. J.A. Nichols. It was during that time that the first parsonage was built. Brother G.T. Hinton succeeded Bro. Nichols in January of 1944. During Bro. Hinton's ministry, the old sanctuary was found on the back of the property and a brand-new sanctuary was built in its place. It was dedicated during November in 1952.

Bro. W.A. Frye was pastor from August 1955 to August 1962. While Brother W.J. Runnels served the church from September 1962, until July 1969. The church built the educational building on the south side of Church

Avenue and started the Dalkeith Mission. The present parsonage was built while Brother Charles Johnson was pastor during the early 1970 until April 1972. Brother Harvey English was pastor from June 1972 through May 1975 and led the church in a major renovation of the old auditorium. Brother Davis Ramsey was pastor from February 1976-through March 1978. In April 1978, Brother English was called again and served until October of 1979. In November 1979, Brother Adolph Bedsole was called as interim pastor and served in that capacity until he was called as pastor in March of 1980. Brother Bedsole led the church in surveying the entire area to find prospects and instituted a workable visitation program. Also, during that time, the church bought a brand-new "Rodgers" organ.


During October in 1982, Brother Richard Bloodworth assumed the pastorate. In 1987, the church bought a Yamaha grand piano and completely refurbished the auditorium which included painting, carpet, new pew upholstery and drapes. Brother Richard Maddox served as pastor from December of 1989 until June 1995. January 1991 gave witness to dedication of the former home of Mrs. Alma Lee Jones, which the church bought and named it, "The Jones House." It was used for Sunday School, VBS and youth group meetings. The home was remodeled in 2006 and is used as a Youth Minister home today.

In June 1996, the church called Brother Mike Stroud as pastor, with his lovely wife Sister Robin and so he is the present Pastor today. At that time in history, I reported Brother Mike's arrival in the Old Wewa News in the mid 1990's. I found the article when I was reading through the Old Wewa News newspapers a few months back.

Due to the growth of the church and answered prayers, they have added a 16,200 square foot Family Life Center that was completed in February of 2007 (which I lovingly nicknamed, "Noah's Ark") The FLC has a fellowship hall/gymnasium, kitchen and classrooms, and serves the Church and the community of Wewa for various functions. Wewahitchka First Baptist Church also has an ongoing bus ministry running on Sundays and Wednesdays. To God Be the glory for His increase in souls. Thank the Lord for such works in our community as well as all the other ministries in our area.

Several years ago, I counted how many churches were in the Wewa area, there were 21 at the time. Then I looked at the population of Wewa proper, approximately 2200 folks live here. Now that is amazing! 100 people average per church. "God is Good! God is Great!" The Youth Minister Brother Allen Singley would say, back in the 1990's, when my children were part of youth group. Now they are all grown up and having kids

and grandkids for themselves to enjoy. Time passes fast, if only we could enjoy those moments again. (Note: The historical history above, for the most part, was provided by Mrs. Ferald Greer; who is a great source of local history.



WEWAHITCHKA CITY FIRE STATION NEWS-CONCERNS- LACK OF PROGRESS!

In the last city meeting, Mayor Gaskin mentioned about the lawsuit between the City of Wewa and contractor Tommy Hamm company Winterfell. The contractor who did not complete the new fire house project on time (by December 26, 2021, as agreed). In an interview with our local TV station, Channel 13, Mr. Hamm was asked, "What is it like working with the city of Wewahitchka on their new firehouse?"

 "I have never ever in my career of 15 years ever worked for a bunch of people as incompetent and inept as is the city commission of Wewahitchka."

YET! City commissioner Mr. Ralph Fisher is known for his excellent work in the construction business of this same type buildings all over the panhandle. He has over 40 years of experience in commercial and private home building. Mr. Jackie Husband, our local engineer, he and his crew are some of the finest in the panhandle and are used and recommended by many (including Gulf County). Mayor Phillip Gaskin is well known, his work quality is superior as well, he too has been in the construction business for 40 years or more.

The City Commission's knowledge and experience have been a major asset to our little city for many years now, and they have never made bad decisions, that I am aware of when it comes to construction and contracts with other businesses during their time on the city board.

The Mayor and Commissioner Fisher always seem to be a step ahead and ask tough questions of contractors and engineers about projects the city is hiring for. They are very much keen on what is happening and ask the right questions during city meetings of those that must come before the board on construction projects. Commissioner Brian Cox also is very keen on how a Fire House operates, and needs.

So, I personally feel Mr. Hamm's comments are unjust and will soon be proven to be considered hateful and uncalled for, considering the facts.

During my own investigation in this matter, I have found an eyewitness that saw the concrete floor being poured on a very rainy day, and a pump was used to remove water at one end of the building as they poured concrete at that same time in another end of the building. The rain was coming into the floor area adding to the mix and watering it down, reducing its quality and strength, the witness told me. Mr. Fisher saw the same event as I questioned him on the matter later during the construction, as he too was worried over the floor concrete construction.

During a city meeting, Mr. Fisher was asked by the public and the City Commission itself, to go and inspect the project and report back to the city commission of his findings. This was due to the various concerns of the citizens over the lack of movement of the project and the rumored poor-quality construction by Winterfell construction crews that were rampant in Wewa.

Mr. Fisher did so, then had a cell phone call with Mr. Hamm of his findings and observations of the roofing crew and concrete work. He told Mr. Hamm to read the contract and especially note page 3 about the roof construction.

Mr. Hamm and our commission did not see eve to eve on his construction and his lack of movement in the firehouse construction overall. I, as well as other Team Chipola members were checking the construction site from 2nd Street and noticed a lack of construction crews on beautiful days as did many other citizens of Wewahitchka. As it was said to me in an interview, after Mr. Hamm's comments on Channel 13 News, "We maybe hicks, but we are not stupid hicks!", a comment made in a joking manner. The truth of the matter folks is that the construction of the firehouse was and is sorry and slow coming, as so many citizens complained to our City Commission, as time went on. As so many folks that live in the Wewa area are in the construction business including our own City Commissioners. Wewa had to act after Winterfell Construction Company did not meet the contracted deadline after they granted an extra 72 rain days to Mr. Hamm's construction company's timelinedeadline, as he asked.

He was to hand over the keys to the completed firehouse on December 26, 2021, after the rain days were figured in. NOPE! NATTA! No keys! And the firehouse still sits incomplete to this day! It saddens me to see our new fire house sit without the beautiful, well maintained fire trucks sitting in their new castle, facing 2nd Street made ready for the next fire call.

As the frustration grew, the city board did all they could legally to give Winterfell rain days and other requested things important to the completion of the building, the city was under a FAMA Grant completion date.

As I travel around our fine city, around Gulf County in general, as well as Bay County, comments are made to me to watch YouTube to see more about Mr. Tommy Hamm. And so, I did.

Today the city is still involved in a lawsuit with Winterfell Construction and its Bonding Company. Now, as of the July meeting the city is to sue the Bonding Company and ordered our city Lawyer to make hast! The latest word is that Mr. Hamm's Lawyer finally sued the correct city (they had tried to sue Port St. Joe on this manner, and has yet to serve The Wewa City Mayor, as it proper in this type Lawsuits), thus the lawsuit was dismissed by the judge, meanwhile, the city fire trucks, and equipment are temporarily parked in the city barns on 7th Street, awaiting their new home. Ms. Michelle Jordan, the city lawyer, continues to work behind the scenes to get our fire station situation dealt with legally, but has not commented much on the situation, as lawsuits can take time.

I told the city council of my own research in finding a contractor that has built several fire stations in North Florida successfully. The contractor (Mr. Jason Alderman, the North Florida area leader of MADRID Engineering Group-CPWG) was interested in finishing the project for the City of Wewa.

Since the contractor's termination, no one is allowed to enter the building. So, it sits with no doors and unfinished construction and wooden walls exposed to moisture. See YouTube video by Burnie Thompson

The Commission has decided to borrow the money and finish the firehouse, then sue the Bonding Company.

A BUSY BEE BIT OF WEWA HISTORY THE MOVIE MADE IN WEWA "Ulee's Gold" Starring Peter Fonda

Back in the day, when I started "The Wewa News" in 1995, a movie was about to be filmed in Wewahitchka and in some other



locations in the Panhandle area to create what is famously known today as the movie 'Ulee's Gold" starring Mr. Peter Fonda (the son of the famous actor Henry Fonda) as well as others including Patricia Richardson of "Tool Time" a funny TV show loved by most Americans; and a young teen named Jessica Biel, who would go on to be famous as well. The director was named Mr. Victor Nunez who happened to be traveling through Wewa when he discovered L.L. Lanier's fine tasting Tupelo honey, and so the story of "Ulee's Gold" was born.

The Lanier family (L.L. and Ben) of Wewa were instrumental in the development and financing of the film. The movie made its arounds to the world theaters, in DVDs and on TV. It has become a must-see video to watch if you know anything about the sweetest little city in Florida.

Many locals were in the movie (I was offered a part as an extra by the casting director in Papermakers Credit Union one afternoon but told her that I would rather report about the filming of the movie to the locals then be in the movie itself). I was thankful to enjoy the filming from the back of the camera on Main Street, then in front of the camera.

Ben and Glynnis helped with the film's production, Ben taught Peter Fonda how to work the bees for the movie and his family was cast as extras as well (you can see them in the restaurant scene filmed in Apalachicola sitting at a table). Ben played a key role in making Fonda look like a real beekeeper in the movie. It is told that all the swamp scenes and bee yard scenes were filmed on Lanier property. I loved to show family and friends, which come to visit, the old truck that was in the film. Not sure if it is still there today. Hmmm... Just a final note folks! Peter Fonda (who passed away in LA from lung cancer on August 16, 2019, at age 79) did receive an Oscar Nomination for his role as the beekeeper Ulee, a U.S. Veteran-Beekeeper in the movie.

- Master Gardeners can fulfill their volunteer hours in a variety of ways, including: answering horticultural questions, participating in community and school garden projects, giving educational programs to the public, supporting youth activities, and more.

THE WEWA LIBRARY

It's that time again! City and county officials are preparing budgets for the next fiscal year. Have you ever wondered how the Gulf County libraries are funded? Here is a little information about how our library works. We are part of the Northwest Regional Library system, which includes three counties (Bay,

Gulf and Liberty), and is headquartered in Bay County. Gulf County is by far our main source of funding, along with the City of Wewahitchka and the City of Port St. Joe. We also get some funds from the State. All these government entities provide funds that cover the operating cost of our facility, and Gulf County's funds cover operational costs for both libraries in the county. Operating costs include, but are not limited to staff salaries, electricity, and water. The City of Wewahitchka owns the building that the Charles Whitehead Public Library is in, so they also pay the building insurance and provide maintenance for the building. We are grateful for all that our county and city commissioners do to support our library!

Still, after running costs are covered, funds for programming and items such as books, magazines, newspapers, DVDs, and audiobooks are limited. There is a very small budget for these items, and it is split between the two libraries. Recently, a group of Wewahitchka citizens created an organization to support the library: The Friends of the Wewahitchka Library. This organization - a 501(c)3 - raises money to supply books and other items that cannot be bought within our limited budget. The Friends also volunteer to aid with programming. Since their start, they have already bought new tables for the conference room and take-home craft kits for children. If you would like to join the Friends of the Wewahitchka Library, or donate to help us grow, please contact the library at (850) 639-2419 for more information.

Over the last couple years, the library has experienced many challenges from Hurricane Michael and COVID-19. Nevertheless, the need for our library has never been greater. New programs and services are constantly being added to help our local community. Of course, with the addition of these services, as well as rising cost in the economy, added funds would be extremely helpful. The Wewahitchka Library would appreciate any direct donations to aid with the growing needs of our wonderful library. Your financial support is valuable to us in continuing to supply the level of service we offer.

Wewahitchka Library hosted a children's summer reading program art contest, "Oceans of Possibilities. One winner from four age groups was chosen by totaling the in person votes and Facebook votes. Each child received \$25.00 from the Friends of the Wewahitchka Library. IS THE FLORIDA SUNSHINE LAW VIOLATED IF THE COUNTY COMMISSION COMES TO WEWA AREA TO TALK WITH CITIZENS? THE ANSWER IS NO! SUNSHINE LAW MANUAL QUOTED BELOW:

"3. Community forums sponsored by private organizations A "Candidates' Night" sponsored by a private organization at which candidates for public office, including several incumbent city council members, will speak about their political philosophies, trends, and issues facing the city, is not subject to the Sunshine Law unless the council members discuss issues coming before the council among themselves. AGO 92-05. Compare Inf. Op. to Jove, January 12, 2009, concluding that a public forum hosted by a city council member with city council members invited to attend and participate in the discussion would be subject to s. 286.011, F.S. Similarly, in AGO 94-62, the Attorney General's Office concluded that the Sunshine Law does not apply to a political forum sponsored by a private civic club during which 22 GOVERNMENT-IN-THE-SUNSHINE-MANUAL commissioners express their position on matters that may foreseeably come before the commission, so long as the commissioners avoid discussions among themselves on these issues. And see AGO 08-18 (participation by two city council members in a citizens police academy does not violate the Sunshine Law; "[t]he educational course is not changed into a meeting of a board or commission . . . by the attendance and participation of members of the city council in the course work of the academy")."



The Constitution for the United States of America...Lets take a look!



Article VI: The Senators and Representatives before mentioned, and the members of the several state legislatures, and all executive and judicial officers, both of the United States and of the several states, shall be bound by oath or affirmation, to support this Constitution. 

CHIEF "PREACHER" J.H. GLASS June 1971 On a hot and rainy day in mid-July my neighbor, Chuck Johnson, and I were heading back to Wewa from a county meeting and decided to take a short stop at Roberts Cemetery in Honeyville.

He wanted to see it, as he was new to Wewa and kept forgetting to, look see. As we walked the rows, I was amazed how many folks I knew or knew about that are buried there. We stayed about an hour, looking at nearly all the grave sites.

I have been wanting to go get the wording on Preacher Glass' tombstone for The Wewa News, so I could share the words with my readers, he was an important part of Wewa history for sure.

He was an amazing lawman, and his memory is so important to us locals to not forget his legacy. He helped so many folks, mainly boys, that were heading down the wrong road. He quickly showed them the error of their ways or wish they had listened to him. He knew what he was talking about. So here is word for

word what is written about him on his tombstone that lays over his remains, I have been told that Sheriff Frank McKeithen was trained by Preacher and loved him very much. Sheriff McKeithen wrote these endearing words that are engrave on his gravesite:

THREE MEN DIED TODAY

Three men died today.
