## CITY PLANNING BOARD RECOMMENDS NO!

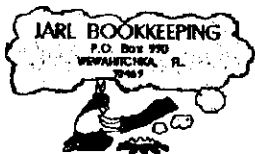

## WEWA WOMEN'S CLUB: THE EARLY DAYS-A BIT OF HISTORY!

In 1932, Wewahitchka, recently voted the county seat of the new county of Gulf, was a sleepy small community of around 900. The main sources of income were Tupelo honey, turpentine, and tourist enjoying the fishing on the famous Dead Lakes.

Thirteen of the local women felt the need of a civic and social organization and organized "The Idle Hour Club."

Their names are listed below. Perhaps the reader may recognize the family names.

The first meetings were held in homes until an old store building was loaned to them. They furnished it with chairs, tables and dishes for refreshments. One of their first activities was to sponsor a "Clean Up Town Week."

Our country was in the midst of a Great Depression and the WPA (Works Program Administration) was started. It was under this program and through the efforts of local people, particularly Mr. J.A. Whitfield local supervisor of WPA, that the town acquired a community clubhouse. After the completion of the clubhouse, the keys were turned over to the Idle Hour Club members who had given so much time and money to the project.

Each year at the annual meeting, the members elect three Trustees to serve three-year terms on the Board of Trustees. There is a total of nine Trustees who are charged with establishing basic policies and reviewing activities of our Cooperative.

Our power supplier is Gulf Coast Electric, Inc. Our Co-op is a private enterprise, and is owned by its members and not by the public at large. The people who use the services of the Co-op are also its owners. **THIS MEANS YOU!**

All monies that are **not** used for doing business are returned to you (the members) in Capital Credits.

It is important for the Co-op to be efficient in doing business by cutting waste, developing better ways to operate more effectively. It should provide outstanding service to the membership (which is their reasonable service), and provide information to the individual members so they may save on their power bills. It should also make available, lightning protection devices and education to protect your private electrical appliances, for your home or business.

I feel that my 25 years in the electrical and electronic field; my time working as a volunteer teaching leadership and organizational management to individuals at the Co-op; repairing electronic devices for the Co-op to help reduce the operating cost over the past 3 years, has made me well qualified to serve on the board of trustees.

In the past four years I have developed an insiders understanding of the organizational and operating practices in which time I have offered many cost saving ideas to the managers.

I have developed a great concern for the Co-op in general and I feel my presence on the board of trustees will provide a fresh new pool of ideas to help reduce the cost of doing business without the loss of the service to our members. ### **WATER LEAKS CAN BE COSTLY - MONEY AND WATER SAVING TIPS!**

According to the Wewahitchka City Hall, a hole one quarter inch in size over a 30 day period can cost you 395,000 gallons on your water bill for your residence or business, 98,000 gallons for a 1/8inch, 24,000 gallons for a 1/16 inch, and 6,000 gallons for a 1/32 of an inch hole in your water pipes. So please don't let that leak remain unattended or it could cost you much more than the repair bills to have it fixed.

If you are on a pump system and not on city water your light bill will reflect the leakage, because the pump will run more often in order to keep your tank filled.

One costly item in your home is that old commode. It's most likely a Toilet that uses 7.5 to 9 gallons per flush, times the number of people living in your house, times the number of flushes. This can add up to big bucks!

Well, one solution is to replace that old commode with a new 1.7 gallon per flush toilet. It will take about two man hours for a handy man to install one, and cost about \$40.00 to \$50.00 for the new water saver commode depending on where you purchase it.

If you can't afford to replace your commode, then you could place a few bricks in the tank, or a large plastic bag of water in the tank to take up space. There by, saving water at every flush. Over a years time this could be a big savings on your water bill and less of a strain on the city water system.

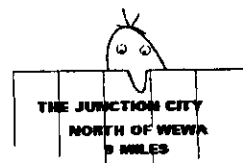

This includes a trip to Milford, Connecticut, the main headquarters for Subway. This trip was a two week training course that over 90 people participated in. Jamie and Robin passed the course which allowed them to operate the Subway franchise here in the Wewa community and create their new business called North Florida Subs, Inc. One road block in reaching their goal was meeting a parking space requirement in the City of Wewa based on the comprehensive land plan, however, the city of Wewa Commission met on February 26, 1996 and made way for Subway to continue and start construction sometime in March.

Why Subway everybody asked? According to Jamie; he and his wife looked into the franchise due to his wife's liking of the quality of food it offers. Since Jamie and Robin purchased the old Citizens Federal Bank building, formerly the Old Wewa Post Office, they decided this would be an ideal location. ## WHS Is Considering Block Scheduling by L. A. Mathes

You may have heard recently about a new style of scheduling that many counties in Florida have begun using. "Block scheduling", in it's simplest form (there are many variations) refers to a different approach to the daily schedule of high school students. The style presently being studied in Gulf County is called "4X4 Block", in which a student attends four classes each day with 90 minute periods. This allows the student to complete a course in one semester, rather than the whole school year. A little math shows you the student taking four periods would complete 4 courses the first semester. Then he/she registers for 4 more classes the 2nd semester, and when finished will have earned 8 credits for the year. In four years time (9th - 12th grades) the student could earn as many as 32 credits, rather than the 24 or so credits they presently can earn.

With a new program there are always some advantages and some disadvantages, which the administrators and school board will have to carefully study and discuss. As we become more familiar with the plan we will introduce it to parents and students, but there's not room in this column to fully cover the pros and cons. Right now it appears to be an innovative way to furnish students with many more opportunities in High School using the same basic time schedules. Most counties in our area have either already switched to this or are contemplating switching because of the apparent advantages.

A few advantages can be noted. For example, less time is wasted changing classes, since student only change four classes. Ninety minute classes would allow students to become more involved in the four classes, allowing more in-depth work and study than the current 50 minute periods allow. Students also need to adjust to four instructors a day, compared to six. Since most block schedules are set up to allow students to take two "difficult" courses and two "electives" each semester, students should be able to concentrate their efforts more effectively and produce better grades. Presently students must take 7th period classes or summer classes to gain additional credits for special honors. The "Block" would eliminate the need for this. There are more advantages, but I can't cover them all (and don't claim to know them all-yet).

As always the case, there are some questions that will need to be answered. One question always asked is what about absences? A student who has missed class several days due to illness might have a difficult time catching up (because each missed class is 90 minutes long rather than 51 minutes). The answer is part of the question - 90 minutes allow the student additional "catch-up" time, plus more individual help from the instructor to aid in catching up. School already using "the Block" report gains in attendance.

Another area of concern is that sometimes a student might not retain learning if there are gaps in the sequence of courses such as math, etc. This problem is overcome by teachers reviewing some previously covered material at the beginning of each new course, just as they do following summer vacation. Again, schools already in this system report in research that retention loss has not been a problem.

What about students transferring in or out of our system? As more and more schools change to block scheduling, as seems to be the case, there will be fewer conflicts of this type. Right now, we do what has to be done - work students into classes and bring them up to speed as quickly as possible.

If you're listing pros and cons on a balance scale, it appears the 4X4 block schedule offers more pros, and if properly used would be a better, more productive use of the school. If you have a chance to attend a session about the "Block", I hope you'll get involved and make your thoughts known.
