# THE CITY OF WEWA IN GOOD FINANCIAL SHAPE!

During the April 22nd meeting of the City Commissioners a Mid-year financial statement was discussed and issued to the public. The statement gave good news. The City of Wewahitchka has over half a million dollars in the bank in CD's and over \$104,000 in General funds, Water and Sewer funds, in ready cash. All this money is collecting over \$30,000 interest for the tax payers of Wewahitchka.

According to the Board, the city is in very good condition and will continue to improve in the future. Anyone interested in the details may get a copy of the statement at the city hall between 7am and 4pm.

Applebaum, Shuler, Daigle, and Cothran is not the name of a new, local law firm. However, the names are those of area Attorneys who volunteered their time and expertise on the 12th of April for the Judgment Collection Workshop, organized by Gulf County Judge Bob Moore.

Each Attorney spoke on a topic related to the process of collection of a final Judgment in relation to creditors trying to collect debt owned to them legally.

Attorney Steven Applebaum, whose office is at Panama City Beach, provided information about properly establishing the Judgment to create a lien on the debtors property. Attorney Michael Shuler, a partner in the firm of Shuler and Shuler of Apalachicola, discussed both the informal and formal discovery techniques. Attorney Robert Daigle, the managing attorney for North Florida Legal Services in Panama City, spoke on debtor exemptions. Attorney Monica Cothran, a partner in the firm of Davenport, James and Cothran of Panama City, discussed the procedures for levy and garnishment.

Judge Bob Moore commented the audience had many questions and seemed to enjoy the presentations. The audience was comprised of representatives of business and individuals from through-out Gulf County.

My Mother also insisted on knowing where we were at all times. You would think we were on a chain gang or She had to know who our something. friends were and what we were doing.



#### **Mower Safety**

It's that time of year again. So bring out your mowers and check the oil and battery water before you get started. Although mowing a yard is not at the top of the hit parade of activities, it's a chore everyone must do. Thousands of people are injured, some fatally, each year in mowing accidents. The following are some safety tips for a safe and pleasurable mowing season:

- Read your operator's manual and become familiar with your mowing machine and weed eater.
- 2. Know the location and functions of each control. This may help you shut down fast in an emergency.
- 3. Make sure safety devices, such as guards, shields and switches are in place and are in working order.
- 4. Before adding fuel, let the mower cool down. Always add fuel outdoors, never in a garage or a shed. Gas fumes are heavier than air and could explode.
- 5. Inspect your lawn for anything that can be thrown by the mower, causing damage or injury.
- 6. Do not mow in areas where people, especially children, are.
- 7. Stop the blades, then the engine and disconnect the spark plug wire before you put your hands or feet near the blades.

In addition to the above tips, for riding lawn mowers consider:

- 1. Never carry passengers.
- 2. Always look behind the mower before you back up.
- 3. Mow up and down instead of across slopes. This will reduce the chances of the mower tipping over.
- 4. When the mower stops going uphill, stop the blade and slowly back down. Never back riding lawn mowers with the blade turning.
- 5. Remove the key when you leave the mower. Children could start your mower and cause injury to themselves or others.



The Board voted to give the residents of Wewa 60 days to comply with the 911 system or the city workers would post the numbers for them and charge the owner of the property. The Commissioners are worried that without the proper display of the house numbers, our citizens would be in danger of delayed response time in an emergency

#### WEWAHITCHKA WOMAN'S CLUB THE EARLY DAYS (PART 3)

The establishment of a library in the community building was the big project in the thirties and through the efforts of Mrs. Irene Briscoe Britt as chairman, the club realized this ambitious project. Assistance was given by the County Commission and the WPA.

By 1939 membership had grown, the Woman's Club had a home, and it was on its way. Then tragedy struck. In 1942, fire destroyed the lovely log community clubhouse and the nation became involved in World War II. Only the piano, a few chairs, and two tables were saved from the fire. Over 3,000 books burned, as well as a valuable law library donated by Mr. A. W. Briscoe whose wife and daughter (Irene B. Britt) were members of the club. The building was insured for \$3,000 and the contents for \$1,000.

Meetings were then held in the homes of members until Mr. J. A. Whitfield loaned a room in his store building. It was large enough for dancing and recreational activities. The club members held their meetings there and involved themselves in selling War Bonds as well as other civic and war activities. The club sponsored Sunday invitational dinners for men in the nearby military bases.

During the war years, the club treasury was about depleted. Mrs. Irene Britt, daughter of Mrs. Briscoe, club president, tells this story:

"Things were so upset from war conditions and there was so much defense work being done that the club did well to have regular meetings. The club had no funds but was reluctant to give the go ahead for a play to be produced. My mother told the club that on a 'no risk, no gain' level, she would take the responsibility of the cost involved. She gave free room and board to the out-of-town lady who came in to direct the play using local talent." The play netted over one hundred dollars for the depleted treasury.

Highlights from the Wewahitchka City Commission Meeting 8 APRIL 96

House numbers. The board voted to give the crizens of Wewahitchka 60 days to have their new house numbers displayed. If numbers are not up, the City will put them up and charge the owner of the property. Senior Citizens who are unable to put their numbers up can call the city for assistance.

Commissioner Jones expressed concern over the apparent lack of progress with the CDBG Housing Rehabilitation. Applicants are asking about the status of their homes. Mr. Minchew will call David Hines to get an update on this program.

Mr. Ben Pridgeon asked the board to make a decision regarding his property on Hwy. 71 N. He asks that the City provide sewer service or allow him to put a septic tank in and be exempt from sewer service if it ever became available. After a lengthy discussion the City agreed to provide sewer service. The type of service will be determined when Mr Pridgeon provides the City with a preliminary plat of his property.

The board approved 2 variances to set-back lines requested by Mr. Will McLemore (Dixie Dandy.)

- Variance to Conservation Set-Back Line-Remove old freezers and extend back wall 12 feet, to put new freezers in.
- Variance to Minimum Front Set-Back Line- Remove gas pumps and install a canopy type of gas service in the front of building.

Kelly Jo Bailey's probationary period ends on April 17, 1996. The board approved to make her a permanent employee.

The Commission approved a proclamation petitioning the Gulf County Commission to up-grade the north end of the county's ambulance service. The proclamation reads:

**Proclamation** 

The City Commission of Wewahitchka Florida appreciate the dedication of the Wewahitchka Volunteer Ambulance Service, who have unselfishly given their time and effort to the people of North Gulf County. They have done an outstanding job as volunteers.

However, when technology is available that could save lives, it should be available to all the people of dur community.

Advanced Life Support (ALS) is provided to the people of South Gulf County, we believe the people of North Gulf County should have this type of service also.

Therefore; We the City
Commission of Wewahitchka
petition the Gulf County
Commission to provide Advanced
Life Support ambulance service to
North Gulf County.

Approved this 8th Day of April, 1996, by the Wewahitchka City Commission.

- The board approved the purchase of a light weight flip phone for the on-call person.
- Next City Commission Meeting will be held on April 22, 1996, 6:30 P.M. at City Hall. All citizens are invited to attend.
