NEW CITY HALL IN THE WORKS

Wewa-During Mayor Grady Booth's first official meeting on the 14th of October the new city hall was discussed in detail. Mr. Don Minchew, the City Manager, stated the deadline for a \$100,000 grant was November 18th and the project needed to be finalized soon.

The final design, marked for Commission approval was presented during the meeting. Do to the short time frame in which to work on the last minute changes the board approved Mr. Minchew to complete the plans for the grant.

The new building will hold office spaces for the city, a city meeting room, and a community center/storm shelter that will be able to handle high wind conditions during bad weather.

The building has an L shape design with a drive up window and ample parking. The proposed location is the T-Ball field just behind Main Street Center. The Commissioners stated that the T-Ball field would be moved to T. L. James Park with the other ball fields.

A School Board Member Speaks! HIGHER GRADUATION REQUIREMENTS EDITORIAL- By: Mary Pridgeon

When the Governor vetoed the School Prayer Bill he also eliminated a number of other excellent provisions which were a part of the same bill.

One of these provisions included higher graduation requirements which the State Board of Education by resolution recommended that School districts adopt. Although some of the district staff recommended delaying implementation of these new requirements, I felt it was important to initiate them immediately since it will take at least four years for full implementation.

Any new requirements must be initiated at the ninth grade level in order to be fair to the students. Fortunately, the other School Board members agreed with me, and the new requirements were approved for beginning ninth grade students at the August 1996 meeting.

The new requirements include a 2.0 grade point average on a 4.0 grading scale (currently 1.5) and Algebra I or a series of courses equivalent to Algebra I. Also, in order to assure that graduates are competent readers, students will be tested for reading ability in grades 5,6,7 and 9, and those scoring two grades below grade level will be required to take remedial reading. This is a major significant requirement because reading is basic to all other subjects and life in America.

The School Board had previously changed the number of credits required to graduate from the current 24 to 28 with the 1996-97 ninth graders. The new block scheduling allows up to 32 credits over a four-year period. All of these new requirements comprise a beginning step in raising the overall standards of our local educational program.

Research has proved over and over that higher expectations will result in greater achievement. We have recently received the new Sunshine State Standards from the Department of Education. These standards identify what our students should know and be able to do during each of four grade groups: PreK-2, 3-5, 6-8 and 9-12. Many of these standards are already in effect in our schools.

Tests will be developed for all of these standards and will be completely implemented by 1999. Successful mastery of these standards should have our students prepared to enter the modern business world.

COMMODITY DISTRIBUTION

U.S. Department of Agriculture surplus commodities will be distributed to eligible area residents on November 19th and 21st. The food will be distributed at the Senior Citizen's Buildings in Port St. Joe and Wewahitchka.

The distribution in Port St. Joe will be on Tuesday, Nov 19th, from 1:00 PM until 3:00 PM ET, and the distribution in Wewahitchka will be on Thursday, Nov. 21st, from 12:00 PM until 2:00 PM CT. Recipients must have a current commodity card to receive their commodities. There will be no registration at the distribution centers. Anyone who has questions concerning their eligibility or would like to sign up should call 229-9112, 639-5068, or come by the Commodity Office in the Gulf County Courthouse prior to these dates.

Wewahitchka residents may come to the Old Courthouse on Wednesday, Nov. 20th, from 12:30 PM to 4:30 PM CT to certify for commodities.

Any household whose gross income is not in excess of the State established maximum percentage of the poverty line for the appropriate household size or who can prove its eligibility for Food Stamps, Aid to Families with Dependent Children (AFDC), Supplemental Security Income (SSI), or Medicaid is eligible to receive the USDA foods. Documents accepted as proof of eligibility include proof of eligibility in the above programs. As an alternative to providing such documents, a household may simply complete an application giving total household income.


Rules for acceptance and participation in the program are the same for everyone without regard to race, color, national origin, age, sex or handicap.

THE GREAT AMERICAN SMOKE OUT

To help those with the habit, the Great American Smoke out Day, Thursday, 21 November, sponsored by the American Cancer Society, is an upbeat, good natured attempt to encourage tobacco users (smokers, dippers, chewers) to voluntarily give up nicotine for 24 hours. A successful quitting experience often convinces people to permanently break their tobacco addiction.

The Great American Smoke out is a perfect opportunity to start you smokers on you way to quitting and adopting a healthier lifestyle.

In addition, if you quit you'll save money. If you're a two-pack a day smoker you could save between \$750 and \$1500 per year. Not only will you save but society could save over \$2 billion per year in costs related to tobacco illnesses. For each pack of cigarettes that's over \$4 per person per year.

As a caution when quitting, nicotine withdrawal symptoms (including anxiety. irritability, difficulty concentrating, restlessness, tobacco urges/cravings, headaches or drowsiness) may present a safety hazard in a few individuals. Symptoms are highly variable, depending on the person and how heavy a tobacco user. Onset may occur within hours of tobacco use cessation, and may last up to 3 weeks. Recommend that tobacco users attempt 8 hours abstinence prior to the smoke out. Those who find withdrawal symptoms severe can try nicotine gum. Also if you want to try nicotine patches, you first must try the gum. Stop your tobacco use, be among the millions of Americans participating in the Great American Smoke out. Good Luck!

IS YOUR CHILD SMOKING?

The facts cannot be ignored; if a parent smokes, then his or her child smokes. If your babysitter smokes, then your child inhales the same dangerous chemicals. When your child spends the night with grandma and grandpa who use cigarettes, then so will the grandchild.

It is not uncommon to see parents and grandparents smoking in the presence of children. Few parents would purposely or knowingly expose their children to a room filled with benzene (a cancer causing flammable liquid), formaldehyde (a disinfectant and preservative), ammonia (a poisonous gas used in bug spray and fertilizer), and hydrogen cyanide (a poisonous rat killer), yet these are just a few of the chemicals that come off the end of a burning cigarette.

If you can smell smoke, your child is breathing secondhand smoke. A child in a smoky room or restaurant for one hour inhales as many bad chemicals through secondhand smoke as he would by smoking 10 or more cigarettes. A child continually exposed to cigarette smoke has a greater chance of developing colds, bronchitis and pneumonia, chronic coughs, and reduced lung function.

What can parents and grandparents who smoke do? Stop smoking! Some parents think

that stopping now is useless because the damage has already been done. This is not true - by stopping, parents can rapidly reverse the damage to themselves and their children, not only of cancer but pneumonia, recurrent ear infections, and other problems.

Ask to be seated in the non-smoking section of restaurants. Make sure your child care provider does not smoke. Ask visitors not to smoke in your home. Don't allow smoking in your car.

Also, if you're planning a family, think about it: Smoking retards the growth of the unborn child, infants of smoking women average 6 ounces less than infants of nonsmoking mothers; smoking increases the incidence of infant mortality, statistics show a direct correlation between smoking during pregnancy and the incidence of spontaneous abortion and stillbirth.

Give them clean healthy air to breathe.



The Wewa News Interviews District One Candidate- Johnny Stanley

On the 29th of October I contacted Johnny Stanley by phone and requested that he answer five questions that I felt needed to be asked of a potential County Commissioner. Here are the questions and his answer to them:

1. If elected, how do you plan to resolve the Life support Ambulance Service problems in the North End of the county?

Answer: "I believe the North end needs our own Emergency Service, complete with full time Medical and Driver support. I find it totally unthinkable about the recent Wewa High School tragedy and the time it took for an Emergency response. I would like to see and will support the City of Wewa and it people in getting Advance Life Support."

2. What is your view of the half cent sales tax the school system wants?

I really believe that Wewa wants their own Unit for faster response time. I understand that Wewa S.A.R. organization have been recognized by the Gulf County Board of Commissioners. Also, they are under one year trail basis without county funding. I will support the Wewa S.A.R. thru-out the trail period and if it works, I will continue to support both ends in their S.A.R. efforts."
- 4. Why do you feel you are the best candidate for District One Commissioner position?

In November 1990-91, President Bush declared the month of November as National American Indian Heritage Month. This time has been set aside to recognize American Indians for their contributions to the nation since colonial times.

According to the 1980 census, there are almost 15 million Native Americans living in the United States of America. The term "Native American" is used to describe the 504 recognized tribes, including the 197 Alaskan Native groups such as the Eskimos and the Aleuts. About 100 tribes have become extinct since the arrival of Europeans on American soil. There are roughly 300 Indian reservations in the United States, the largest of which is the Navajo Reservation, which extends through out 16 million acres in Arizona, New Mexico, and Utah. Two hundred and fifty-five different Indian languages are still spoken by tribes today.

Each tribe is distinctive because of its customs, religion, language, and form of government Indian nations are sovereign nations with inherent powers to determine citizenship, levy taxes, and regulate marriage, divorce, and Indian nations can establish a adoption. monetary system, make war and peace, and form alliances through treaties. The United States Supreme Court has stated that the power of the tribe to establish courts to enforce its laws is no. dependent on federal law. It is inherent in the tribe's sovereignty. Most tribes are not subject to the Constitution of the United States or the Bill of Rights, but have their own constitutions. In fact, those who framed the government of the United States used the pattern of the Iroquois Confederacy as a model.

The Native American people are the only political group specifically identified in the United States Constitution. Consequently, the United States and Canada must recognize the inherent sovereignty of the Indian nations and their right to self-government. Whatever power the United States or Canada exercises over these nations is received from the particular tribe or nation-not the other way around.

Although other minority groups have wanted full integration with the White majority, it has been just the opposite with Native Americans. Native Americans have fought and died to remain autonomous. Their determination to stay free and their frustration at losing land to the expansionism of the last two centuries forced many warrior-leaders to take drastic measures.

Atrocities commented by the colonists against the Native American have been widely documented. After one such massacre, Benjamin Franklin wrote of the plight of the Native American people:

"If an Indian injures me, does it follow that I may revenge that injury on all Indians? ...It is well known that Indians are of different tribes, nations, and languages, as well as the White people. In Europe, if the French, who are White people, should injure the Dutch, are they (the Dutch) to revenge it on the English, because they,

too, are White people? ... What had the little boys and girls done? What could children of a year old, babes at the breast, what could they do that they must be shot and hatcheted? And in their parents' arms! This is done by no civilized nation in Europe. Do we come to America to learn and practice the manners of barbarians? But this, barbarians as they are, they practice against their enemies only, not against their friends."

Native American warriors not only prided them-selves on their prowess on the battlefields in defense of their land and people, but also on their abilities as speechmakers. Since they usually knew no written word, they had to recall from memory everything they talked about, having no notes to refresh their memory. In their tribal conferences, every man of valor and responsibility was given a chance to express himself. Each brave took his turn in speaking, used many gestures, and sought approval of every important phrase.

There were 371 treaties made with all of the North American Indian tribes and ratified by the Congress of the United States. However, there were hundreds of other treaties which were never ratified. Thousands of speeches were made by these warriors during the treaty negotiations. Although they usually lost something as a result of the treaty, when it came to oratory, they seldom came out second best.

The oratorical skill of the Native American leader was, as one author put it, "one of the deadliest weapons the Indians had."

ANGER

Editoral-Anger is all around, your boss, your co-workers, your spouse, yourself. How do you handle it, by getting angrier? By letting it eat away inside you? There are better, healthier ways of dealing with anger.

If you are dealing with an angry person, first get in touch with your own feelings. Are you also angry, or afraid, guilty, or anxious? If so, try to calm yourself, someone needs to be in control. Take several deep breaths, talk to yourself, say things such as, "I am calm, I will not get upset, I will not let this person make me loose control."

(Don't use others for a Scapegoat for the way you feel or your reacting to your feelings).

Listen to the other person and let them know you are listening and understand what is being said. Avoid strong emotional labels such as "angry" or "furious." Responses using "I" messages are more effective. "I feel uncomfortable when you yell at me." "I feel like yelling back at you, and I know that will just make things worse."

Don't touch an angry person. Make sure you give him adequate space, at least arms length. Keep your voice calm. Ask questions that require the person to think. Ask content questions rather than feeling questions. You already have an idea how the person feels. Remember, your goal is to calm the person down so rational thought can take over.

Anger is a physical energy that needs to be dissipated. If you've ever noticed feeling drained after an angry reaction, you will recognize how much energy goes into anger. It can be hazardous to you health.

There are many times when anger is an appropriate reaction. For example, it is appropriate with a child who runs out into a busy street. However, in most cases, it is better to replace anger with other more reasonable reactions.

The person who gets angry in rush hour traffic is not exhibiting a reasonable response. A reasonable response would be to allow extra time so one won't be late or if your job will allow, to change time of travel to avoid time of travel to avoid peak travel times. Listen to relaxing music or a taped book can help. Viewing time in the car as a transition period, as an opportunity to think about something you usually don't have time for is helpful.

A simple change in attitude can make a major difference in how one feels. I would use that long drive from Panama City or Port St. Joe to calm down after a long day. I like to think up articles for the newspaper or just enjoy the trees along the way.

If you are often angry, you need to look at why and what the anger is doing for you. Does it make you feel bad? Does it last a long time? Does it make others afraid of you? Are you really angry at yourself and taking it out on them? A "yes" to these questions may indicate a problem.

What may cause anger? Many times low self-esteem, fear, hurt, disappointment, frustration, or feelings of unfairness or injustice may be behind it? Understanding this can help relieve or even prevent the anger. Returning to the example of the child in the street, your anger is really a secondary reaction to fear of harm to the child.

Instead of focusing on your anger, plan how you can change the underlying problems and get positive results in other ways. Learn to negotiate and clarify your point of view in a calm manner. If you're going into a situation where you know you might get angry, plan how to react.

If you do loose control, don't be afraid to apologize. People are willing to except explanations. Don't forget, continued outbursts followed by apologies soon loose their effectiveness. Anger does not bring respect. As one anonymous writer once said, "Speak when you're angry and you'll make the best speech you'll ever regret."

This is the last chance to ask for your support regarding the ½cent sales tax to finance the renovation of Port St. Joe Elementary School. By next week's article you will have already made your choice known. I'll just repeat what I said before - the money for this project has to cone from local input.

The state simply will not furnish the amount that's needed, plus it would eliminate dollars needed to keep the other schools maintained if the state funds that are available are used as part of the construction funds. Only approximately \$190,000 is available. Estimates for the complete renovation needed are about \$4 million. This has to be financed with bonds, and a substantial increase in advaloram taxes (property taxes) could be the alternative to the 'scent sales tax.

Many of our people shop in Panama City, paying sales taxes that do not benefit Gulf Go. at all. The only time you would pay this ½c sales tax would be on items normally taxed in our county. Plus, we will be helped by visitors, vacationers, and those just passing through who will help by paying the ½cent tax on their purchases. This is the fairest way to finance these bonds. When paid off, the ½cent sales tax will end. So it's in your hands.

Let's do our share to provide a clean, modern place for these children to learn. Every other school in the county has come first.


