## WEWAHITCHKA CITY FIRE STATION- CITY COUNCIL DISCUSSES THE REPAIRS AND DAMAGE BY WINTERFELL CONSTRUCTION AT CITY MEETING

Mr. Jackie Husband told the city commission at the September city meeting that all the wood structures in the unfinished building had to be completely removed due to poor construction and water/weather damage. The 6-inch concrete was inspected again, and he told the commission where the concrete had to be replaced and or added since it was an incomplete install.

Mr. Gene Hanlon discussed the situation of the city suing the construction company as did others asking about the Bonding company movement on the money for the repairs and finishing the project. The lawsuit between the City of Wewa and contractor Tommy Hamm’s company Winterfell Construction is still pending.

The City Council in a vote of 5-0 passed a decision to borrow the money to complete the Firehouse and to sue the bonding company for Winterfell Construction for the cost and damages to the city and the unfinished part of the firehouse construction during the August meeting. During that meeting the mayor directed the city, in house Engineer, Mr. Jackie Husband, to develop a list of what needed to be repaired, completed, and/or fixed to finish the fire house and then put out notices for construction bids, Mr. Husband has been working on that project full bore!

### MIRANDA RIGHTS GIVEN AT ARREST

U.S. Supreme Court had something to say about that, LETS TAKE A LOOK!

Here's what the U.S. Supreme Court said in an appeal that questioned the Miran warning that peace officers are supposed to give before questioning a suspect.

"In the Miranda case this Court promulgated a set of safeguards to protect the constitutional rights of persons subjected to custodial police interrogation. The Cou held that unless law enforcement officers give specified warnings before questionir person in custody and follow specified procedures during the course of interrogatic any statement made by the person in custody cannot, *over his objection*, be admitted in evidence against him at trial." *Michigan v. Tucker*, 417 U.S. 433, 443 (1974).

If you live elsewhere, go see your local rep nearest you. With musculoskeletal conditions, the VA rates conditions based on pain, limited motion or too much motion, damage to the bones, diseases like arthritis, etc. The ratings for Hip and Thigh conditions varies from 10-90%, which depends on various factors. In addition, increased benefits may be available for hip pain caused by hip replacements and those who experience markedly severe residual weakness.

The definition of "advocate" is further specified in Executive Order 10450 which for the purposes of enforcement supplements 5 U.S.C. 7311.





## DARE TO TAKE A TEST?

During my time in the U.S. Coast Guard, my last 7 years of my career one of my duties was to be a Drug and Alcohol Counsellor and Coordinator. Later, I was a DAC at Gulf C.I. for a short time, as well.

My fellow Coasties would come to discuss their alcohol issues voluntarily or by Command orders, based on the issues at hand in their lives. I created a Self-Referral program and tested it for approximately three years before the Coast Guard saw the success of it and used the program throughout the USCG to help other Coast Guard members and stations with their alcohol abuse issues. Here is the test I would give in my office before deciding what to do next.

**A self-audit test-a 10 question questionnaire to see if you may need help with your personal issue with alcohol use and or abuse of it. In the private quarters of your own home. You can do a self-evaluation:**

**(Notice: This is for educational purposes only, so be honest with your own self. Get help locally if your numbers add up, please!)**

### 1) How often do you have a beverage having alcohol in some form in it?

- Never (0 points)
- Monthly or less (1 point)
- 2 to 4 times a month (2 points)
- 2 to 3 times a week (3 points)
- 4 or more times a week (4 points)

### 2) How many beverages or glasses having alcohol do you have on a typical normal day when you are consuming alcoholic beverages?

- 1 or 2 (0 points)
- 3 or 4 (1 point)
- 5 or 6 (2 points)
- 7 to 9 (3 points)
- 10 or more (4 points)

### 3) How often do you have more than 4 or 5 alcoholic beverages during one Sitting?

- Never (0 points)

- Monthly (2 points)
- Weekly (3 points)
- Daily or almost daily (4 points)

### 4) How often during the past year have you found that you were not able to stop using alcohol once you had started drinking alcoholic beverages?

### 5) How often during the past year have you did not do what was considered normal by others because of alcohol use?

### 7) How often during the past year have you had a feeling or suffered remorse or guilt after drinking alcoholic beverage(s)?

**8) How often during the past year have you been unable to remember what happened the night before because you had been drinking alcoholic beverages?**

**9) Have you or someone else been injured because of your drinking of alcoholic beverages?**

**10) Has a relative, a friend, a doctor, a PA or another health worker been worrying over you or been concerned about your use or abuse of alcoholic beverages?**

- No (0 points)
- Yes, but not in the last year (2 points)
- Yes, during the last year (4 points)

**Total points:**

**Alcohol screen score**

<b>0 to 7 points:</b>	Low risk
<b>8 to 15 points:</b>	Medium risk
<b>16 to 19 points:</b>	High risk
<b>20 to 40 points:</b>	Addiction likely

**Please consider your Risk factor here and get local help soon.**

- **Low risk** (0 to 7 points): You most likely do not have a problem with alcohol. Continue drinking in moderation or not at all, would be much better.
- **Medium risk** (8 to 15 points): You may drink too much on occasion. This may put you or others at risk. Try to cut down on

alcohol or stop drinking completely, if you are willing and able.

- **High risk** (16 to 19 points): Your drinking could lead to harm if it has not already happened. It is important that you cut down on alcohol or stop drinking completely. Ask your doctor or PA for advice on how best to cut down and get local help.
- **Addiction likely** (20+ points): It is likely that your drinking is causing you harm and well as those around you. Speak to your doctor or PA or an addiction specialist asap. Ask about medications and counseling that can help you stop drinking. If you are dependent on alcohol, do not stop drinking without the help of a health care professional. You got this, get help, it is all around you.

Just ask! First step. Pray!
